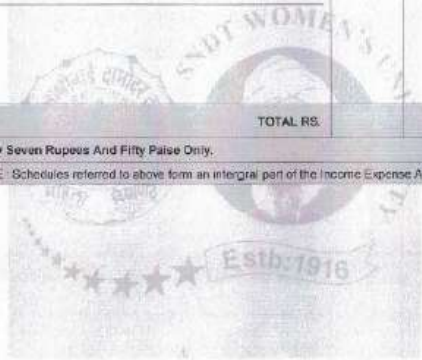


Disclaimer
